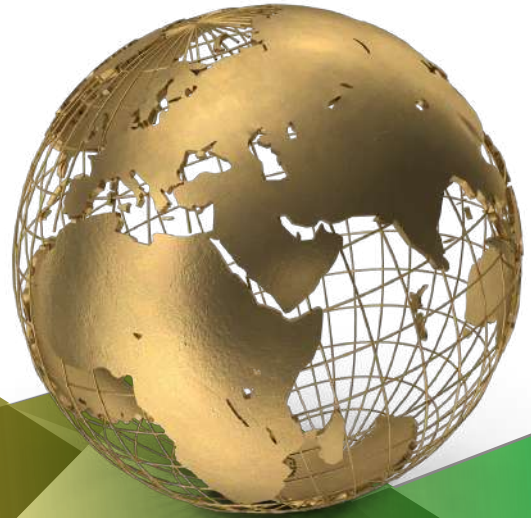

ABOUT THE AMAN UNION

The AMAN UNION was established in accordance with the provisions of its Charter ratified on 28th October, 2009.



VISION

OBJECTIVES

- Development of credit information agencies as well as development of debt-collection agencies, training centers and other institutions that contribute to the progress of export credit insurance industry in Members Countries.
- Encouragement of exchange of information, technical assistance, expertise and consultation among Members.
- Carrying out studies and research, issuance of bulletins and publications and, organization of forums and conferences relevant to the union purposes.

ORGANIZATION STRUCTURE

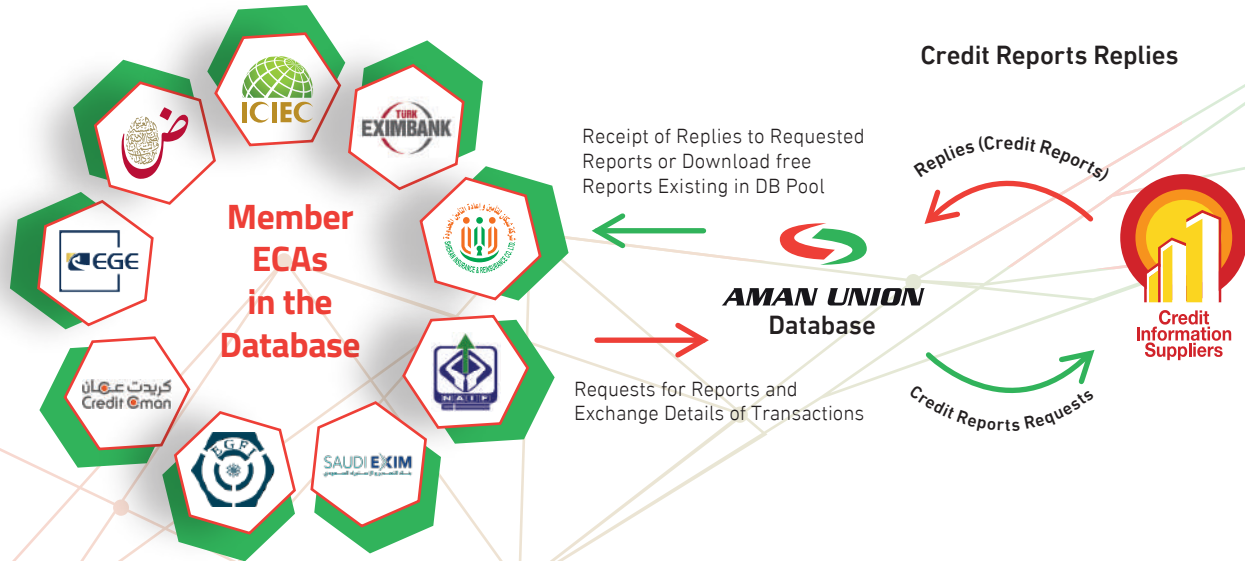
1. **The General Assembly:** Consisting of the representatives of all the Union Members.
2. **The Executive Council:** The executive and policy making body of the Union. Its membership consists of seven Full Members.
3. **The General Secretariat:** The permanent administrative body of the Union. The General Director of the Arab Investment and Export Credit Guarantee Corporation (DHAMAN) and the Chief Executive Officer of the Islamic Corporation for the Insurance of Investment and Export Credit (ICIEC) and General Manager for Turk Eximbank are alternately, every two years, the Secretary General of the Union.
4. **Standing Committees:** The Short-Term Export Credit Insurance Committee, the Structured Finance Insurance Committee, and the Data Committee

THE AMAN UNION DATABASE PROJECT

The Database is an initiative by the AMAN UNION and is the first of its kind in the Arab and Islamic region, established for the benefit of national export credit insurance agencies in the region and enables the Subscribers in the Database to share and purchase credit information reports, credit opinions on entities worldwide and to exchange their underwriting experience on buyers and banks.

The Database was officially launched during the 4th Annual Meeting of the AMAN UNION, held in Qatar on 10 December, 2013 and is currently providing its services to its 9 Members of ECAs. ICIEC's role in the Project was instrumental as all legal documentation and Credit Information Services Agreements were prepared by ICIEC in addition to participation in the Technical Team assigned by AMAN UNION to manage the database which is composed from ICIEC, Dhaman and Turk Eximbank.
